ONLINE ADMISSION NOTIFICATION 2025-26-27

In pursuance to Directorate of Skill Development J&K's Admission Notice issued under endorsement No. DSD/401/Trgs/2025/1521-1611 Dated: 08-05-2025, **Online applications** are thus invited from desirous candidates for seeking admission in **Govt. ITI Udhampur** for the academic session 2025-26-27 in various Engineering/Non-Engineering Trades having duration of Two years/One year/6months for **free & Self- finance seats** being run under NCVET/SCVET Scheme and commencing from 1st of September 2025, for which the forms can be uploaded from **15**th **of May 2025.**

The desirous candidates having minimum age of **14 years as on 1**st **September 2025** with no upper age bar have to fill up the admission forms available online at ITI admission link (http://itiadmissions.jkdsd.in) present on the official website of Directorate of Skill Development J&K i.e.:- www.jkdsd.in.

The last date for applying online is up to **30**th **of May 2025.** The candidates have to fill up the complete details which include basic details of student like name, parentage, qualification etc. online in the portal and have to upload the soft copies in .jpg format (with size between 20KB to 200KB) of the following documents online only:

- 1. Marks Certificates of Qualifying examination
- 2. Date of birth Certificate.
- 3. Category Certificate (SC/ST/Ex-serviceman/Physically Handicapped/EWS/OBC) if any
- 4. Aadhar card.
- 5. Domicile certificate should be produced at the time of admission in ITI.

The candidates after finalizing the profile and application online will be required to deposit the printout of the system generated application completed in all respects along with self-attested photocopies of above-mentioned required documents uploaded on the portal and deposit the prescribed fee of Rs.100/- (One hundred only) per three trades (03) against a proper cash receipt from Govt. ITI Udhampur.

IMPORTANT NOTE:

- 1. The applying candidate has to submit printout of system generated application along with requisite self-attested documents at Govt. ITI Udhampur.
- 2. The candidate shall deposit the fee @ Rs.100/- (one hundred only) per **three trades** at Govt. ITI Udhampur against a proper cash receipt.
- 3. Selection will be made purely on the basis of **academic Merit** in the qualifying examination prescribed for each trade (both for Free &Self finance Seats)
- 4. On successful completion of training in trades affiliated under NCVET/SCVET Scheme, Certificates will be awarded by the National /State Council for Vocational Education &Training.
- 5. Candidates, who have already undergone training in any of the trades of ITIs, can apply for admission in another trade two years after completion of previous training course. However, for the ensuing academic session their admission is considered in any of the trades having poor response.
- 6. The Admission in Self Financing Trades is subject to the minimum prescribed enrollment and availability of the instructors to run the trades purely on self finance basis only as per the standing guidelines issued by the higher authorities.
